ROBERT A. SWIFT

I am a senior member of the Philadelphia law firm of Kohn, Swift, & Graf, P.C., and have been practicing law for 45 years. I litigate civil actions in the state and federal courts. I am a member of the Pennsylvania Supreme Court, the United States Supreme Court, nine US Courts of Appeal, and several US District Courts. My practice focuses on complex litigation with an emphasis on international human rights. I argued the first human rights case in the US Supreme Court, and the first Superfund case there. I also counsel and represent corporate clients.

I was lead counsel and chief trial counsel in the *Ferdinand E. Marcos Human Rights* case, the first class action human rights case ever filed, where I obtained a verdict of almost \$2 billion for the torture, summary execution and disappearance of 10,000 Filipinos. I also served as lead counsel in class action cases against Swiss, German and Austrian banks and insurance companies for human rights claims arising during the Holocaust. I am signatory to settlements of Holocaust cases totaling \$7.5 billion which was distributed to 2 million people. In his book on the Holocaust negotiations, Imperfect Justice (2003), U.S. Deputy Treasury Secretary Stuart Eizenstat wrote:

Swift was an atypical class-action lawyer: the consummate gentleman, understated, calm, reserved, and flexible. He wanted to convert the concept of criminal responsibility from the Nuremberg trials into civil liability in favor of human rights victims, still a novel theory of law.
